

ABSNC accredited organizations are required to submit an annual compliance report to ensure ongoing adherence to accreditation standards. Certification programs initially accredited or reaccredited in the 12-month reporting period, will not be required to complete an entire report, unless noted changes have occurred (e.g., Bylaws revision) since accreditation or reaccreditation was granted.

The annual compliance report will be completed in the ABSNC credentialing management system, <https://absnc.learningbuilder.com/>. All details requested are for the previous 12-month reporting period (ending June 30th of the current year).
